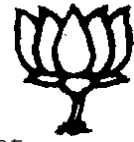

Sub: Unhealthy Voters List - Manipulation?

**Ref : Hundreds of voters with single name/bogus -
171 Mankhurd Assembly, Mumbai**

Dear Sir,

The voters list of thickly dominated Bangladeshis is not only faulty but manipulative and unhealthy. Till now, we have submitted 3 different representations to the Election Commission on the basis of our field survey :

1. Double names with the same photo, different photo I-card
2. Voter with only single name, e.g. Ansari....., Ansari....., Ansari.....
3. Thousands of double/duplicate/similar names in the voter list
4. Well planned effort to register bogus voters during the August & November 2008 Voter Enrolment Drives

We are sorry no serious efforts have been made till now by the local Collector of Mumbai Suburban Dist. to stop well planned operation to infiltrate 171 Mankhurd voters list.

We have submitted details along with documentation, evidence on all the above 4 points. For example :

➤ Bangladeshi with double I card (Annexure 2) :

➤ 17,000 out of 29,000 new enrolment applications have been rejected by ERO office. These were supported by forged/bogus documents duly authenticated. No action has been taken against the people who master-minded this operation.

In the above situation, we would request the Election Commission :

1. Criminal action against all those who have obtained double I card.
2. Directives to the Collector, Mumbai Suburban Dist. to appoint special machinery to find out all such double, duplicate, bogus voters by scrutinizing whole voters list of 171-Mankhurd.
3. Criminal action against all those who submitted, authenticated bogus, fraudulent documents for new enrolment.
4. **Appointment of Special Observer for 171-Mankhurd Assembly, Mumbai.**

Request to do the needful.
